The need for strict monitoring and timely utilization of allocation funds made under various Heads has been emphasized from time to time. In this connection, I would like to inform you that during the discussion on Demands for Grants, the Parliament Standing Committee for Home Affairs took a serious note of the fact that due to under utilization of the funds during the initial quarters of the Financial Year, the plan component allocation to the Union Territories is reduced at R.E stage resulting in various difficulties in completion of the projects identified for the plan period. The Committee has, therefore, recommended that all out efforts should be made by the UT Administration to utilize the funds allocated in such a way that the pace of expenditure is maintained at all stages particularly during the initial quarters of the Plan Period.

It may also be appreciated that one of the reasons for cut in the allocation at the R.E stage is normally due to less utilization of funds in the initial quarter and it is therefore, necessary, that all out efforts are made to pace the expenditure in such a way that maximum expenditure is incurred in the initial quarters of the Plan Period.

3. In view of the above, it is requested that strict and regular monitoring of the expenditure be undertaken with a view to ensure timely utilization of the allocation made under various Heads to overcome the drastic cut on RE stage. A monthly report on the expenditure incurred under various Heads may also be forwarded to this Ministry, by 5th of every month positively.


