Student belonging to other state/UT may submit application to their domicile state/UT-Further criteria may be seen in guidelines (copy attached). 1. Income Certificate:

For Daman & Diu : may be issued by concerned Secretaries of the Panchayats once the same is attested by the respective Sarpanch and countersigned by the respective Block Development Officer for village. Such certificates may also be issued by Mamlatdar.

For DNH : May be issued by Mamlatdar.

2. Domicile Certificate: Issued by Mamlatdar.
