
ORDER UNDER SECTION 144 OF CRIMINAL PROCEDURE CODE.

WHEREAS, in view of the forthcoming General Election to Lok Sabha Election - 2019, the holding of **public meeting, Rally, use of Loud Speaker, slogan shouting etc, from Y- Junction, Bhitwadi to Dholar Char Rasta, Moti Daman** can cause inconvenience to the general public and any kind of vehicle movement has to be restricted during the nomination process from 10.00 Hrs to 16.00 Hrs.

THEREFORE, in exercise of the powers under section 144 of code of Criminal Procedure 1973, (No.2 of 1974) I, **Charmie Parekh, Sub Divisional Magistrate, Daman** hereby order that holding of public meeting or gathering of public for celebrating any function or gathering by any private associations/ organizations, political parties or groups in the Collectorate premises and in the 100 Mtrs of Collectorate, Moti Daman is strictly prohibited with a view to avoid any untoward incident or law and order problem in the future and can be organized only after taking prior permission of District Magistrate. Also, the road from Y - Junction, Bithwadi to Dholar Char Rasta, Moti Daman will be closed from 10.00 Hrs. to 16.00 Hrs. The general public may use the alternate road existing from the Y - Junction, Bhitwadi to Dholar char rsta.

This order shall come into force and shall be effective with immediate effect from **28/03/2019 upto 04/04/2019 (both days inclusive) from 10:00 Hrs to 16:00 Hrs.** unless withdrawn earlier.

Any person contravening this order shall be punishable under Section 188 of the Indian Penal Code.
