### NOTIFICATION

The Administrator, Daman and Diu and Dadra and Nagar Haveli is pleased to grant permission under Rule 99 (3) of the Goa, Daman & Diu Excise Duty Rules, 1964 to the Hoteliers/Retailers, Bar & Restaurant owners and Event Manager for extending the time to keep open beyond the prescribed hours from 11.00 p.m. on 31/12/2019 to 2.00 a.m. on next day i.e. 01/01/2020 on payment of the following charges/fees:-

The Permission shall be subject to following conditions:-

1. Loud Speaker or public address system shall not be used at night from 10.00 p.m. onwards. The volume of loud speaker shall not be raised to a level causing nuisance to the public. The objectionable/obscene language shall not be used on the loud speaker.
2. The applicant is responsible for any untoward incident, breach of peace etc. They are directed to submit an undertaking on affidavit, stating that there will be no nuisance of any kind after 11.00 p.m. upto 2.00 a.m. for which period the applicant has obtained permission of the Excise Department to continue to operate their sale activities.
3. They will also state in the said affidavit that they will be responsible/liable for any kind of incident which may occur during the above period for which any criminal case is registered by Police Department for breach of any conditions of CrPC and the department will not be held responsible for granting permission for extension of the period.
4. The permission is liable to be cancelled or revoked at any time.

5. The requisite amount shall be deposited in treasury by challan. A copy of paid challan may be uploaded in the IERMS system through the respective login Id issued by the Excise Department, Daman for Daman district and Collector, Diu for Diu District for permission to keep the license premises open from 11.00 p.m. on 31/12/2019 to 2.00 a.m. next day i.e. 01/01/2020.
6. Action as per law will be taken against the defaulters, whose licensed premises are found open without obtaining permission.
7. The permission will be valid only for the period from 11.00 p.m. on 31/12/2019 to 2.00 a.m. on 01/01/2020.
