
(1) **SHORT TITLE, APPLICATION AND COMMENCEMENT:**

- (i) These rules may be called the Administration of Daman & Diu, Group "C" (Non – Gazetted / Non Ministerial) post in the Coastal Security Scheme of Police Department, Daman & Diu for the post of Sukhani (Assistant Sub Inspector) Recruitment Rules (Second Amendment), 2012.
- (ii) They shall come in force with immediate effect.
- (iii) The educational and other qualifications required for direct recruitment for the post of Sukhani (Assistant Sub Inspector) in column No.8, entry No.(4) shall be substituted as under :-

Essential :-

(4) Having 03 years of sea experience prior to obtaining certificate of competency as Tandel / Master (Mate) duly certified by Marine Department or Fisheries Department of Daman & Diu or seving Leading Seaman of India Navy or Uttam Navik of Coast Guards having 3 years rank experience.

SHORT TITLE, APPLICATION AND COMMENCEMENT

(i) These rules may be called the Administration of Damam & Diu (Recruitment) Rules, 2015 and shall be known as the Administration of Damam & Diu (Recruitment) Rules, 2015.
